They have recently been re-started but require a two week quarantine. Inpatient and outpatient community programs were all negatively affected by COVID19 resulting in decreased admissions to community programs. Efforts were implemented to limit patient stays at inpatient settings due to COVID19 resulting in a decrease of LOS for adults in state psychiatric hospitals for less than one year.
7	The increase in expenditures related to EBP for ESMI is caused by the full implementation of two additional CSC teams that were initially contracted in FY 2019 but did not begin full services until FY 2020. The decreases in expenditures related to Other 24 Hour Care and Ambulatory/Community non-24 Hour Care are due to the effects of Covid-19 during the third and fourth quarters of SFY 2020.
12	The difference between having 7% and 9% of our total clients report as co-occurring in any given year is within our typical range of variability. Our co-occurring populations are reliably always under 10% of total clients, anything less than that we consider insignificant.
