All	DCF: There is some duplication in the tables of the clients receiving community services, resulting from characteristics of the CT Department of Children and Families' Programs and Services Data Collection System (PSDCRS). Client data entered into PSDCRS is unduplicated within each provider. Normally data is de-duplicated across providers by assuming that clients are the same if they have the same first and last name, DOB, and gender. For most of the tables in this report (those not involving SED) we also require that they have the same race, Hispanic/Latino origin status, health insurance coverage and living situation, so if any of these data elements are reported differently between providers this client would be counted more than once. This is done because all of the data elements just listed are used to classify clients in one or more tables in the MHBG report, so if they were not included in the de-duplication process as just described, the totals in the tables would be inconsistent with each other. There is also possible duplication by simple data entry errors, such as different spellings of a client's name by different providers.
All	There are consistent differences in unduplicated client counts between the Client Level Data (CLD) file and the URS tables. The internal DMHAS and DCF reports used to produce the URS table data submission appear to be duplicating clients. Consequently, the CLD counts are more accurately representing the Connecticut populations for the CMHS block grant.
5A/5B	DMHAS collects an "Other" category for race. These clients have been recoded to the "Unknown" category.
6	There was a restructuring and conversion across hospital, residential and PRTF beds, resulting in reduced census during the period of transition.
6	DMHAS believes that individuals with serious behavioral health needs should receive treatment in the least restrictive community setting, reserving the use of inpatient treatment to only those instances when medically necessary. This policy, translated into practice, means that the adults who are admitted to State Hospitals tend to require the most intensive treatment available.
14A	A client in the DMHAS system may have multiple demographic records because this information is entered separately by different providers who do not have access to shared data. However, each client has a "master record" in the internal data warehouse. We use this "master record", which has the most complete information, for reporting a client's demographic information in the CLD. In this case, one client may have been initially reported as Asian but then corrected in the master record.
16	Family Functional Therapy (FFT): fidelity: adherence information are recorded on the web-based FFT Client Service System. In accordance with FT protocol, our agency monitors fidelity through the clinical lead. Fidelity is also monitored on an ongoing basis by FFT, Inc. through a variety of measures including the national supervisor who monitors our site. Fidelity is measured weekly by the on-site clinical lead and monthly by FFT, Inc., through our national consultant.
16	Multi-Systemic Therapy (MST): Therapist Adherence Measures (TAM), Supervisory Adherence Measures (SAM) and Program Implementation Reports are used to measure fidelity by Advanced Behavioral Health Inc. (vendor) weekly and monthly.
