All	The major provider of mental health services completed their transition to a new information system. Beginning with FY14 they were able to report nearly all of the required data elements. As a result of this reporting improvement, the Bureau did not need to use the alternative method used for FY13 reporting. The reporting for FY14 is now consistent with the reporting prior to FY13. The increase in the number of people served is due to the improved reporting by the provider.
All	A unique identifier is assigned to all community and hospital consumers regardless of age or disability. Unduplication is accomplished by merging multiple identifiers for a person into a single identifier. Information such as name, date of birth, social security number, Medicaid ID, county of residence, and gender are used to identify cases that may warrant being merged. Access to the Medicaid database is also available and is used to confirm name changes as well as used to determine records to be merged. Medicaid claims files are used as well to confirm the provider and date of service prior to merging cases requiring further investigation. Approximately 150 records are merged each day.
All	Ethnicity is not collected by the hospitals. When an individual receives services from both a community program and a hospital, the ethnicity reported by the community program is used.
2A	Race/Ethnicity: An individual may select more than one race category. If one initially selects only one race and, subsequently, selects a different race; they are considered as having chosen more than one race. If more than one race is selected at any time, they will always be reported as more than one race. In previous years, the last reported race was used when more than one race had been reported. Cases have been identified where an individual may select the majority of available race categories; however, this occurs infrequently and is not considered significant.
