6	Reason(s) for dropping in total Number of Consumers Served in Other Psychiatric Inpatient Settings at the beginning of the year: Mobile Crisis Outreach Teams (MCOT) and increased community expansion of alternative psychiatric emergency service programs, provided increased diversion resources with crisis episodes. Alternately, forensic capacity increased reducing civil capacity in state mental health facilities.
6	Reason (s) for average LOS of children (in facility < 1 year) who were state hospital residents at the end of the year: Youth Empowerment Services (YES) waiver increased enrollment and level of care “Residential Treatment” for youth has provided alternative intensive intervention services.
7	Evidence-Based Practices for Early Serious Mental Illness: The bulk of these programs (i.e., 8 out of 10) started in late FY16. The first full year of operation was FY17, and new programs take time to organize, staff adequately, and deploy. The 26% increase is not surprising. We’re working on adding 10 new programs currently, so I anticipate expenditures will continue to increase year by year until all programs have deployed completely.
7	State Hospital: The variance is due to transformation: Now that we (State Hospitals & State Supportive Living Centers) are one agency, we no longer have IAC’s (Inter Agency Contracts) in place with DADS. We are now ETV’ing (Electronic Transfer Voucher) expenditures for shared services, etc.
7	Other Federal Funds: In addition to fluctuations in contractor expenditures, the increase in other federal funds is likely due to the receipt of new grants targeted toward disaster response efforts (e.g., Hurricane Harvey and flooding within the Hill Country/Central Texas and the Rio Grande Valley. The variance is due to exclusion of \$305K in ETV’s and \$904K in fringe benefits in inclusion of salaries and fringe benefits in 2018 which were excluded in FY 2017
7	Total Administration Expenditures: Main reason is completion of capital projects which were categorize as administration in FY 2017
7	Total Medicaid Expenditures: Medicaid expenditures decreased substantially between 2017 and 2018 due to a shift in Medicaid funding from Behavioral Health Services to the Medicaid program. The shift in funding was intentional and permanent.
8	TOTAL NON-DIRECT SERVICES services expenditure dropped significantly from FY 2017 due to drop in INFORMATION SYSTEM expenditure as a result new cost allocation methodology (based on client counts) whereas before there wasn’t an exact science to calculate an allocation. Basically the cost are now spread out to more of our grants/GR based on that months client counts. Also, a bulk of the expenses were for CMBHS and that project has been winding down.
11	Percent of children/adolescents reporting positively about outcomes dropped significantly from FY 2017. While working on the FY2018 URS tables, we found some coding errors in the FY2017 YSSF files from last year. We corrected the code and updated the YSSF FY2017 URS tables. I understand that there was an issue last year with the “Reporting Positively about Outcomes for Children” domain, in that it increased by about 30% from FY2016-FY2017. When the corrections were made to the FY2017 coding errors, this domain is now back in alignment with previous years and FY2018. with the correction FY 2017 outcome is 60% which is in line FY 2018 outcome at 59%,
16	Total number of consumers receiving ACT services: An increased number individuals identified with high complex need issues who received a lower recommended level of care were deviated to assertive community treatment (ACT) as an appropriate level of care within the continuum of care (18% increase in deviations between fiscal year 2017 and fiscal year 2018).
16A	Reason for significant increase in Adult and children in from FY 2017 to FY 2018; Most of the centers started the EO program in FY17, so they were able to ramp up in FY18
