6	The main reason adult LOS for the state hospital has increased is that we closed our acute (<30 day stay) unit in March 2018. This 4-bed unit accounted for 57 discharges in FY 17 and only 31 in FY 18. These patients' lengths of stay were calculated into the total adult population length of stay. However, we also saw an increase in discharged LOS among our adult civil units. We have studied this issue in depth and are currently working with an outside consultant to find ways to decrease this.
7	We've changed how we collect and distribute costs. Most notably, we have changed our Cost Allocation Plan, which is admin costs jumps. Costs are actually down, but we're accounting for them differently in order to get Medicaid Admin participation. Total Medicaid Expenditures - This increased because of a change in our state plan that gives a broader benefit to the homeless.
14A	There appear to have been errors in the reporting of Hawaiian/Other PI by providers in prior year,
16	Family Functional Therapy increased by program effort. ACT is a new program, so the jump is reasonable. Family Functional Therapy services-our reporting improved inf 2018.
17	Family Psychoeducation services did increase with a program focus. The changes in integrated dual diagnosis and illness self management are probably because this is a small percentage of our clients, and is likely just year variation in the data.
