3	Pennsylvania has been undergoing a significant project in reducing the wait times of individuals waiting for a forensic bed. This includes a high volume of individuals that are being discharged and admitted during the reporting year. Therefore, there will be an increase in the number of individuals served in the Pennsylvania State Mental Health Hospitals.
4	Pennsylvania continues to make improvements in the data collection system to accurately identify an individual's status in employment. The difference in the number of consumers employed and unemployed is due to an increase in the number of records where the employment status was updated successfully in FY 2017/18. Pennsylvania continues to work to reducing the number of individuals where an employment record is not available.
5A	In 2018 reporting we developed a query to pull this information anytime during the fiscal year. For the 2019 report, Pennsylvania changed the method for this metric to use the MH-TEDS discharge file to determine the Medicaid status at the discharge accounting for the increase in clients with non-Medicaid funding and the decrease in clients with both Medicaid and non-Medicaid funding. Pennsylvania feels this is a more accurate method to respond to this metric as it is capturing the funding status at discharge and not over inflating the non-Medicaid counts.
6	Pennsylvania has been undergoing a significant project in reducing the wait times of individuals waiting for a forensic bed. This includes a high volume of individuals that are being discharged and admitted during the reporting year. Therefore, there will be an increase in the number of individuals served in the Pennsylvania State Mental Health Hospitals. OMHSAS had a significant number of individuals with long lengths of stays, specific to the forensic population that were discharged in FY 2017/18.
7A	The numbers on table 7A table were compiled from Pennsylvania's allocations to the FEP sites, and the training money that is allocated to the Pennsylvania Early Intervention Center at the University of Pennsylvania for FEP statewide training and program evaluation. Although Pennsylvania increased FEP allocation in FY18-19 over FY17-18, the program site expenditures reduced during that year, partially due to the development of case rates and more efficient use of funding at program sites as the program sites work towards sustainability.
8	The numbers on table 8 are increased due to a number of factors including: a change of location for the Mental Health Planning Council, an increase in money going toward FEP tele-psychiatry development, an increase in training in response to the SAMHSA CMHSBG site visit, and a cost of living adjustment for administrative costs.
10	MHBG funds for adults with serious mental illness and children with serious emotional disturbance are not counted separately.
16	OMHSAS continues to develop the Consolidated Community Reporting Initiative (CCRI) where County Base Funded MH offices are increasing the volume and validity in data being reporting to Pennsylvania. Additionally, housing has been a priority for counties and is easily identified as one of the top needs in annual plans. Counties continue to prioritize use of HealthChoices reinvestment for supportive housing and as they have developed these programs and are using up their reinvestment they are continuing the programs in part with County Base Funded MH office. Pennsylvania counties have been working hard to reduce the need for out of home placements by increasing the number of family-based teams and other community based treatment services that will keep the child in their home.
