**Screening, Brief Intervention, and Referral to Treatment**  
**Short Title: SBIRT**

The Substance Abuse and Mental Health Services Administration (SAMHSA) is announcing a webinar and conference call for prospective applicants interested in applying for fiscal year 2024 **Screening, Brief Intervention, and Referral to Treatment (SBIRT) TI-24-010**. The webinar and conference call will be led by SAMHSA Center for Substance Abuse Treatment staff.

The purpose of this program is to implement the Screening, Brief Intervention, and Referral to Treatment public health model for children, adolescents, and/or adults in primary care and community health settings (e.g., health centers, hospital systems, health maintenance organizations (HMOs), preferred-provider organizations (PPOs) health plans, Federally Qualified Health Care (FQHC) systems, behavioral health centers, pediatric health care providers, children's hospitals, etc.) and schools with a focus on screening for underage drinking, opioid use, and other substance use. For the purpose of this NOFO, pediatric health care providers are a provider of primary health care to serve youth 12 to 21 years of age.

This program is designed to expand and/or enhance the uptake of SBIRT into routine healthcare and other encounters with children, adolescents, and/or adults for a system-level approach to reducing alcohol and other drug (AOD) consumption and its negative health impacts. These awards support clinically appropriate services for persons at risk for substance use disorder (SUD) as well as those diagnosed with SUD.
